## **Horse Show Reports:**

<u>Tally Ho</u> – Arena footing was poorly maintained until Sunday, competitors were not notified in a timely manner about when classes were running, arenas were quite far from stabling. Question regarding number of members who actually competed in the show

<u>Cross Winds</u> – A few rider injuries, modified adults were moved to help finish at a reasonable time, nice derby course and jumps (situation with a rider jumping a jump was handled well) footing got a little hard by the end of the day Sunday even with attempts to water multiple times throughout the day (heat was a factor)

<u>5 Corners</u>- Lovely horse show, loved 3 rings, derby was well managed, good decision by show management to move jumper classes along, gate at jumper ring did get a bit congested at one point

Showplace- Cancelled. It is unclear as to when the show was cancelled and competitors were notified

Palatine- Great horse show, rings handled rain well, ring crew was not sufficient

#### Discussion from Horse Show Reports:

- A proposed a rule clarification about the deadline to cancel a horse show will be the Monday at 5pm prior to the
  competition. The NIHJA president, NIHJA secretary, and all trainers of received entries and stall reservations
  must receive notification by that time. Show management will incur a fine of \$250 if the rule is violated.
  Exceptions will be considered by the NIHJA board in cases of extreme circumstances.
- Letters to be drafted to horse show management regarding low member attendance and cancellation of horse show. Toni will write and send letters.

#### **Old Business:**

 NIHJA has received communication from a member who has not received their points due to their trainer being in bad standing. The trainer has still not come current with NIHJA for the bad check that was written.
 Member will receive a letter about what action may be taken in order to rectify the situation. (Sari will draft letter and share with the board prior to sending)

## **New Business:**

- We have two new members who are currently not in good standing due to bounced checks at horse shows. RS and AA are to be notified of their bad standing and given the opportunity to come current or points from that competition and any other competition after that point will not be awarded.
