THINGS YOU NEED TO KNOW

ATTIRE

- * Proper show attire is required for all classes. Collared shirt for jumpers
- * Helmets must be worn while mounted. The USEF requires all riders to wear USEF approved head gear.

CLASSES

- * USEF Rules apply if not covered by NIHJA rules.
- * Management reserves the right to cancel or combine classes if necessary.
- * Prizes and 6 ribbons awarded in each class. Champion and Reserve in all divisions. You must be entered in an entire division to be eligible for champion or reserve champion points.
- * Exhibitors are expected to be prompt for their classes, a one minute call will be placed on an open gate.

STALLS

- * Stalls will be available after 12:00 noon on Thursday.
- * Stall reservations and completed entries must be received by April 5 to qualify for a \$25.00 discount.
- * Any stall reservation canceled after 9:00 am on Monday April 9 will be billed to the trainer (*except with written vet excuse)

SCHOOLING

- * Thursday 12:00 noon to 7:00 pm
- * Friday and Saturday until 1 hour before start time.
- * No schooling in show ring on Sunday morning.

MISCELLANEOUS

- * No Smoking in or near barns, show ring or stabling area.
- * A \$35.00 fee will be charged for any returned checks
- * All dogs must be on a leash. We prefer you leave your dogs at home. Owners of loose dogs will be charged a \$50.00 fine.
- * Current negative Coggins is required for all entries.
- * Documentation of Equine Influenza Virus and Equine Herpes Virus Vaccinations (Flukhino vaccine) administered within six (6) months prior to the date of the horse show
- * Any non-stabled show horse will be required to pay a \$50.00 trailer in fee per day.

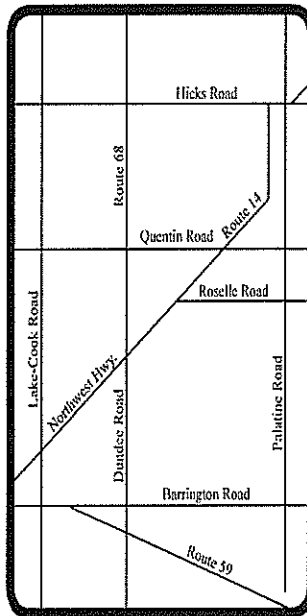
